Tax Investigation: Paving The Way For Criminal Tax Investigation in 2013

The Inland Revenue Board of Malaysia (IRBM) is serious in preventing tax evasion and is working closely with tax agents, stakeholders and other relevant authorities to alleviate its occurrence.

It is a well-known fact that every tax payer thinks about reducing their tax liability. However, with a dishonest tax payer tax evasion is done by unethical practices like concealing income, inflation of expenses and falsification of accounts. Where penalties have proven to be a non-deterrent for tax evasion cases, the IRBM has taken punitive measures such as criminal prosecution with severe penalties and imprisonment upon conviction.

Participants attending this seminar will be introduced to the differences between civil tax investigation and criminal tax investigation. Participants will have the opportunity to understand IRBM's criminal tax investigation procedures and the relevant provisions in the Income Tax Act 1967, The Criminal Procedure Code and The Evidence Act 1950.

Recognizing and practising good record keeping will greatly reduce the risk of additional assessments and penalties.
