Implementation of Guidelines for the issuance of Non-Preferential Certificates of Origin for Year 2025

In order to regulate the issuance of Certificate of Origin, Ministry of International Trade and Industry (MITI) has added and streamlined the existing guidelines for a more effective system of issuing Non-Preferential Certificates of Origin. The New Guidelines are aimed at elimination cheating and forgery of Certification of Origin. They have been implemented on 1 June 2008.

Under the new guidelines, there are new procedures that have to be adhered by manufacturers, exporters or traders to obtain Non-preferential Certificate of Origin. <u>Kindly submit the check list document on 1st January of year 2025 before applying Certificate of Origin.</u>

GUIDELINES OF APPLY CERTIFICATE OF ORIGIN (C.O.)

A. YEARLY REGISTER

The applicant company is required to completed C.O. application with following checklist A, B (Where applicable) on every 1st January of the year before applying Certificate of Origin.

B. ENDORSEMENT

The applicant company is required to submit related document with following checklist A, B (Where applicable) for C.O. application.

- i. Assurance from applicant that the goods to be re-exported have not undergone any substantial processes that may compromise the origin status of the first exporting country, other than the permissible activities as in paragraph 3.4 of this guideline;
- ii. Commitment that applicant shall be fully accountable and liable in case of any fraud, falsification, wrongdoing and/or due diligence related to the details or information declared by the applicant during application for B2B NPCO; and
- iii. Will or intention of applicant to accept any legal action and/or any other possible consequences with regard to fraud, falsification, and wrongdoing and/or due diligence related to the details or information declared by the applicant during application for B2B NPCO.

PART III: CERTIFICATION PROCEDURES

- Application for back-back C.O can only be issued for goods that pass through Malaysia before re-exported to 3rd countries.
- 2. Back-toback / Transhipment NPCO must carry first country origin.
- 3. A valid original Certificate of Origin (1st Country) must be presented.
- 4. The consignment which is to be re-exported with the back-to-back C.O must not undergo any further processing in the intermediate Party, except for repacking and logistics activities.
- 5. In the case of partial shipments, the partial export value shall be shown. The total quantity reexported under the partial shipment should not exceed the total quantity of the 1st Country C.O.
- 6. The period of validity of the back-to-back C.O should not exceed the period of validity of the 1st Country C.O.
- 7. For those who export partial quantity from the imported quantity, kindly attached with the Monitoring Sheet as per Appendix 7.
