# 迎战风暴 · 经济研讨会

## Economic Forum

巴生乡团联谊会主办，本会与雪兰莪中小型企业企业家商会协办的“迎战风暴 · 经济研讨会”于2026年4月19日（星期日）上午10时，在巴生福建会馆礼堂举行。巴生乡团联谊会主席拿督陈治年致开幕词时表示，全球经济局势充满不确定性，华商及华社企业家应未雨绸缪，提升抗风险能力，以在动荡环境中稳健前行。他指出，美国、以色列与伊朗冲突升温，若中东局势长期化，将对全球经济带来冲击，包括石油与天然气价格波动、国际航运通道不稳定及通胀压力加剧，进而影响我国企业经营环境。他表示，本次研讨会旨在凝聚各界智慧，探讨应对经济挑战的对策，协助企业在经济风暴来临前稳住阵脚。研讨会邀请大马厂商联合会名誉会长丹斯里苏添来，以及筹委会主席兼巴生滨海兴安会馆会长丹斯里刘万腾担任主讲人，分享企业经验与经济见解，为与会者提供参考方向。

本会代表出席者为商务暨财经研究组主任黄天佐。

The “Navigating Economic Storms · Economic Seminar,” jointly organized by The Federation of Klang Associations, with our chamber and the SCSME as co-organizers, was held on 19 April 2026 at the Persatuan Hokkien Klang. Federation of Klang Associations Chairman, Dato’ Tan Chuan Nian, said that the global economic outlook remains highly uncertain. He stressed that Chinese business communities and entrepreneurs should take precautions in advance and strengthen their risk resilience in order to navigate through turbulent times steadily. He noted that tensions between the United States, Israel, and Iran are escalating. If the situation in the Middle East becomes prolonged, it will have a significant impact on the global economy, including fluctuations in oil and gas prices, instability in international shipping routes, and rising inflationary pressures, all of which will in turn affect Malaysia’s business operating environment. He added that the seminar aims to bring together collective insights from various sectors to explore strategies in addressing economic challenges, helping businesses to stabilise their footing before the arrival of potential economic storms. The seminar featured Tan Sri Soh Thian Lai, Honorary President of the Federation of Malaysian Manufacturers, and Tan Sri Liu Ban Tin, Chairman of the Organising Committee and President of the Persatuan Hin Ann Pantai Klang, as keynote speakers. They shared their business experience and economic perspectives, providing valuable insights and direction for participants.

Representatives from the Chamber who attended included Chairman, Commerce and Economic Research Committee, Kelvin Ng Tien Chor.

## 南洋商报 礼貌拜访巴生中华总商会 Nanyang Siang Pau Courtesy Visit to KCCCI

2026年6月4日,南洋商报代表团莅临巴生中华总商会进行交流访问。会长拿督陈杰辉向来宾介绍商会的发展概况、组织架构及活跃小组,并邀请南洋商报总执行长李成童先生出席本会 80周年庆典晚宴。

交流中,会长指出本会当前重点工作为维护华商权益及协助企业转型升级,以应对不断变化的商业环境。针对人工智能(AI)发展趋势,会长表示企业应积极学习和善用 AI 提升竞争力,本会未来也将推出相关培训课程,署理会长戴良麟则强调,数码化与自动化已成为企业发展的必然方向,企业若停留在传统经营模式,将难以吸引年轻人才及实现永续发展。

双方也就华商面临的挑战交换意见,包括营运成本上升、新税务措施、国际局势影响供应链,以及中小企业所面对的市场竞争压力,会长认为政治稳定及完善监管对商业发展至关重要,商会将持续向政府反映会员企业的意见与诉求。

此次交流进一步加深了巴生中华总商会与南洋商报之间的联系与了解,双方期待未来加强合作,共同推动华商发展、企业转型升级及社会公益事业,为国家经济与社会发展贡献力量。

On 4 June 2026, a delegation from Nanyang Siang Pau paid a courtesy visit to the Klang Chinese Chamber of Commerce and Industry (KCCCI) for a networking and exchange session. During the meeting, the President Dato' Jeffery Tan introduced the Chamber's background, organizational structure, active committees, and upcoming 80th Anniversary celebrations, while formally inviting Nanyang Siang Pau's Group Chief Executive Officer, Mr. Vincent Lee, to attend the anniversary gala dinner.

The discussion focused on key issues affecting the business community, including the protection of Chinese business interests, business transformation, and the adoption of artificial intelligence (AI). The President emphasized that businesses must move beyond merely understanding AI and learn how to leverage it effectively to enhance competitiveness. The Chamber also plans to organize a series of AI-related training programs in the future. Deputy President Ir. Ter Leong Leng highlighted that digitalization and automation have become essential for sustainable business growth and for attracting younger generations into business succession.

Both parties also exchanged views on the challenges faced by businesses, such as rising operating costs, new taxation measures, global geopolitical uncertainties affecting supply chains, and increasing competition faced by SMEs. The President stressed the importance of political stability and effective regulation in supporting a healthy business environment and reaffirmed the Chamber's role in conveying members' concerns and recommendations to the relevant authorities.

The visit further strengthened the relationship and mutual understanding between KCCCI and Nanyang Siang Pau. Both parties expressed their commitment to enhancing future collaboration in support of business development, digital transformation, and community initiatives, contributing to Malaysia's economic and social progress.

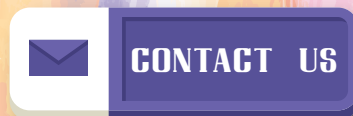
