2. 在我国国际贸易及工业部和中华人民共和国驻马来西亚大使馆的支持下，中总将参展“第四届中国国际进口博览会”并组织代表团赴会，为大马商家提供国际投资平台和机会，协助企业促销产品和服务到海外市场。

Eligible companies are entitled to claim Market Development Grant (MDG). Booths are limited, interested companies are kindly requested to register with ACCIM as soon as possible. Booking fee for one booth is RM 13,000. The organiser has set a more tighten rules and regulations whereby they will only allotted booths to qualified companies upon their review. In this connection, price per booth is subject to availability. ACCIM will refund the booking fee if company application is being rejected by the organiser.

CIIE include the following exhibition areas, ACCIM can refer companies to participate at the exhibition, but whether booth(s) is provided is at the sole discretion of the organiser.
